

DJs for You **COMPANY POLICY**

DJs for You, the "1st Party", understands the **following issues** can arise with events planned in the future and some examples of these are:

CV-19 or other types of National or Global-Epidemics, Severe Sickness, Hospitalization for Emergency Childbirth, Severe Disability, Severe Injury, Death, Insurrection, Rioting, Calls to Civil Service, Calls to Active Duty, Acts of War, Natural Disasters, Venue Disasters and of course any Acts of God.

DEPOSIT payments are NON-REFUNDABLE. But we do allow for some flexibility. The "1st Party" allow the "2nd Parties" to RESCHEDULE their wedding date without any penalties or additional fees. Their deposit is transferred and used for the "RESCHEDULED" date. The "1st Party", always make every effort to secure this "RESCHEDULED" date. The "1st Party" will acknowledge and confirm our availability via text, email, cell or any two of these methods. If the "RESCHEDULED" date cannot be secured, the "1st Party" will gladly REFUND the "2nd Parties" DEPOSIT. The "1st Party" will typically allow 2 years, but may be flexible.

PLEASE NOTE: your original DJ may be unavailable if he has been booked for another event prior to your securing a "RESCHEDULED" date.

NOTE: Should FEDERAL, STATE or LOCAL AUTHORITIES determine that COVID-19 or some other MAJOR HEALTH CONCERN forces them to order restrictions on SOCIAL GATHERINGS that would lead to the inevitable PERMANENT CANCELATION of your event or should other aforementioned issues harm the state, city, venue, bridal party, the "1st or 2nd Parties" or our DJs and there is no option of rescheduling, the "1st Party" will gladly FULLY REFUND the DEPOSIT of the "2nd Parties". The "1st Party", kindly requests the "2nd Parties" provide at least 2 weeks' notice, if possible, via text or email, cell or any two of these methods


Since our beginning in 1999, our Pro DJs have never missed an event.

In addition, should our DJs have any of the aforementioned issues arise or if he has a major residence location changing event, the "1st Party" will make every attempt to convey this directly to "all Parties" with as much notice as possible especially in the event of severe injury or death. The "1st Party" will communicate this orally if possible and then confirm this in writing to the "2nd Parties". The "1st Party" will make every effort to secure and schedule another DJ and inform the "2nd Parties", orally if possible and then confirming this in writing.

However, should the "1st Party or 2nd Parties" find they cannot agree on the suggested replacement DJ, the "1st Party" will gladly REFUND their DEPOSIT.

DJs for You, the "1st Party" cannot foresee every scenario, but we want our clients, their families, their friends and our DJs to be in a safe environment and to have an absolutely wonderful event.
